

Testing

- Providing early diagnosis and linking affected individuals to healthcare services
 - DPH Sexual Health Clinics conducting testing
 - Public Health Lab processing specimen
 - Commercial labs processing specimen
- Supporting healthcare providers in diagnosing, treating, reporting, and educating patients

CHALLENGES

- Availability of testing supplies & trained staff
- Ensuring healthcare providers in a variety of settings were able to offer testing
- Maintaining lab capacity
- Ensuring quick turnaround of results
- Ongoing training of staff and providers

RESOURCES

- Sustained funding for lab operations and related supplies & training
- Incentives for providers and labs



Contact Tracing

- Conducting robust interviews of all cases
 - May need to modify our strategy if the number of cases surpasses our current capacity
- Monitoring contacts for signs and symptoms for 21 days after the last day of exposure
- Issuing Isolation Orders

CHALLENGES

- Insufficient staffing for contact tracing
- Redirecting staff from other responses and core public health activities
- Eliciting contacts

RESOURCES

- Sustained funding for contact tracers to identify others in the community at elevated risk
- Ongoing supports for daily living for individuals who must isolate



Vaccination

- Distribution and administration
 - Public Health clinics
 - Public Health Points-of-Dispensing (PODs)
 - Community PODs
 - Community/Hospital sites
 - Correctional sites
 - City of Long Beach
 - City of Pasadena
 - Targeted Outreach (PEH, CBOs, etc.)
- Technical assistance for vaccinators
 - Webinars & training materials
 - Office hours

CHALLENGES

- Limited vaccine supply and high demand
- Vaccine administration across a vast geography and many providers
- Building or enhancing data systems to efficiently manage/track local vaccine inventory with community providers (i.e., local allocation, receiving, distribution, inventory management, and reporting)

RESOURCES

- Funding & support for community health providers to administer vaccine and conduct outreach
- Ensure sufficient reimbursement for community health providers



Vaccine Eligibility in Los Angeles County

- Monkeypox vaccine is available to gay or bisexual men and transgender persons 18 years of age and older who:
- Had multiple or anonymous sex partners in the last 14 days including engaging in survival and/or transactional sex (e.g., sex in exchange for shelter, food and other goods and needs)
 - Note: If you are immunocompromised (including if you have advanced or uncontrolled HIV), you may be at high risk for severe disease and will be prioritized for vaccination.

Outreach & Engagement

- Information sharing and targeted vaccination strategies for high-risk populations
 - Men who have sex with men, people living with HIV, and others
 - Corrections
 - People Experiencing Homelessness (PEH)
 - Providers and interim housing partners
 - Community and faith-based efforts
 - Telebriefing calls
 - Mobile vaccination events
- Back-to-school planning
 - Telebriefings (e.g., K-12 group w/LACOE; school nurses)
 - COVID-related spaces (e.g., superintendent meetings)
 - Student well-being centers

CHALLENGES

 Limited staffing that must balance targeted outreach and messaging to the general population

RESOURCES

- Flexibility in funding to mobilize COVID-funded community health worker staff
- Funding for groups to conduct community outreach & education



Communications

- Social media
 - Training & sample messaging for Message Ambassadors
 - DPH Channels
- E-mail newsletter
- Media outreach and weekly media briefings
- Public Health Phone Line
- Print materials
 - Wallet cards

CHALLENGES

- Battling stigma & mistrust
- Consistent messaging across different channels
- Engaging trusted messengers
- Leveraging existing mechanisms

RESOURCES

 Sustained funding for communications (e.g., campaigns, marketing in population specific channels, like dating sites), translation, and interpretation services
